## Appointment List

- + Simplified views of information linked to the patient's appointment
- + Shows if the patient has a medication that is being monitored or needs to be flagged so the treating team knows ahead of time that the patient is on specific medication
- + Searches the patient medical record for a defined list of medication and display med orders with the appointment information
- + Administrators can manage the list of medication
